THE FINANCIAL SERVICES SECTOR IS PARTICULARLY VULNERABLE TO THE POTENTIAL HARMS OF UNETHICAL AI. MISGUIDED ALGORITHMS CAN WORSEN BIASES, WEAKEN TRUST AND COMPROMISE THE INTEGRITY OF THE FINANCIAL SYSTEM.

TO MITIGATE THESE RISKS, AI SYSTEMS MUST BE TRANSPARENT, ACCOUNTABLE AND INCLUSIVE, AND SHOULD NOT REINFORCE OR AMPLIFY EXISTING INEQUALITIES.
